A committee reviews the grants submissions to ensure that they fall within the Foundation's mission and enrichment guidelines. The committee submits the qualifying grants to the Board of Directors. The Board reviews the committee's recommendations and budget considerations and votes whether to approve the grant.

4b (Code) (Expenses \$ 10,000 including grants of \$ 0) (Revenue \$ 0)

Campus school site grants - Grants are awarded to each campus to provide instructional strategies that benefit all the students at each campus. Grant requests are submitted by district and campus administration. A foundation committee reviews each grant request to ensure they fall within the guidelines of the foundation's mission and enrichment guidelines. The committee submits qualifying grants to the Board for approval. The Board reviews committee recommendations and budget considerations and votes on whether to approve the grants.

Teacher Enrichment Grants - these grants provide opportunities for teachers to attend seminars and workshops to further their professional development and implement new programs and instructional techniques into the classroom and to share these programs with fellow teachers and staff. Grant requests are submitted by teachers approved by the administration. A Foundation committee reviews each grant request to ensure they fall within the Foundation's mission and enrichment guidelines. The committee submits qualifying grants to the board for approval. The Board reviews committee recommendations and budget considerations and votes on whether to approve the grants.
