Instruction and Student Aid Trevecca Nazarene University is a comprehensive, fully accredited, Christian university offering undergraduate, master’s and doctoral degrees The University offers 91 baccalaureate majors, 20 master’s degrees in the fields of business, science, education, counseling, religion, organizational leadership, and library and information sciences The university also currently offers two doctoral degrees, one post-master’s major, and six certificate programs The University broke an all-time 113-year enrollment record in 2015 Total traditional undergraduate enrollment grew by 100 students to 1,115 (continued on Schedule O)Instruction and Student Aid, continued Critical to this success were two components a 27% increase in enrollment of new students (freshman and transfers) and outstanding retention of current students The 2015 freshman class was the University’s largest freshman class ever, increasing the University’s residence hall occupancy to 99 percent The University’s total student population exceeded 2,600 for the first time in the 2014-2015 school year Trevecca awards institutional, state, and federal financial aid assisting students in developing a plan for meeting their educational expenses The Office of Financial Aid provides guidance and resources to help students and their families bridge the gap between a student’s potential resources and the University’s costs The percentage of traditional undergraduate students receiving financial aid from any source was 94%
