The Organization receives a great deal of support from the community. Volunteers from partner churches and various community organizations serve dinner every night of the year to women and children staying at First Light, Inc.

The Organization had in excess of 10,000 volunteer hours donated to the Organization. The dinner volunteers bring all the food and drink to serve approximately 70 guests each night. Also, on occasions such as thanksgiving, complete turkey dinners are provided for the approximately 50 clients in the scattered-site housing.

The Organization receives in-kind donations throughout the year. At the beginning of each school year, many school supplies and uniforms for the children in the Organization's programs are donated.

Some furniture and other necessary items for living in apartments are donated to help the women in the Organization's permanent housing.

Volunteers also donated many other items such as cleaning supplies, over-the-counter medication, socks, underwear, clothing, etc.
