Alpha-1 Research Network. The Alpha-1 research infrastructure provides support for a network of Alpha-1 investigators worldwide. It is one of the Foundation's most valuable assets and includes the DNA & Tissue Bank, Genetics Laboratory, and more than 80 affiliate Clinical Resource Centers, offering specialized care to Alphas. The Foundation organizes scientific meetings, conferences, workshops and symposia which further the understanding of findings in the field and promotes research, clinical endpoint measurements and other potential breakthroughs. The Alpha-1 Grants and Awards Program is the heart of the Foundation's research activities. Its scientifically rigorous peer-reviewed process provides the framework to evaluate and recommend meritorious research projects for funding within the scope of the Alpha-1 research agenda. To date, the Foundation has invested \$54 million to support Alpha-1 Antitrypsin Deficiency research and programs at 100 institutions in North America, Europe, Australia and the Middle East.

4b (Code) (Expenses \$ 372,843 including grants of \$ 163,100) (Revenue \$ 333,707)

Florida Detection Program. This program has led to testing over 22,000 individuals for Alpha-1 since inception. The goals of the program are to provide free testing to individuals in the State of Florida and to promote Alpha-1 education for healthcare professionals. In fiscal 2015, over 4,300 tests were distributed, speakers were provided for 4 medical grand rounds, 5 lectures providing CME credits, 8 lectures providing CEU credits, and 9 medical related conferences. Activities to educate the public and at-risk individuals are conducted and the partnerships developed with other organizations in the state has led to increased interest from physicians. Two educational meetings for the at-risk population, Alphas and caregivers were held.

4c (Code) (Expenses \$ 608,001 including grants of \$ 531,349) (Revenue \$ 155,000)

Alpha-1 Registry and ACT Trial. The Research Registry includes 52% homozygotes (ZZ) and 34% carriers (MZ or MS) ranging from infants to seniors. The remaining 14% represents participants who don't know, are unsure, etc. The goal of the Alpha-1 Coded Testing (ACT) Study is to evaluate people's thoughts and feelings about the risk and benefits associated with learning genetic information as well as to offer confidential free testing to interested individuals. The study has been very successful in identifying individuals with Alpha-1. The study tested 2,756 individuals in fiscal year 2015. Information that has been collected is the basis for upcoming publications. Over 20,000 individuals have enrolled in the ACT Study since 2001. The Research Registry is a confidential database of diagnosed Alphas and carriers willing to participate in research studies and clinical trials for new therapies.
