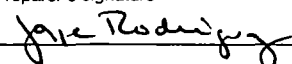

 PUERTO RICO PUBLIC HOUSING ADMINISTRATION (PROJECT LEARN PROGRAM)
 Project Learn is a comprehensive program that impacted 2,224 bonafide residents from different housing projects within the ages 6 through 18, and 1,275 adults through its Family Support program. Participants took part in activities in a fun and secure environment to develop their full potential as productive individuals. Activities supported included: Power Learning (830 participants), Drug Prevention (658 participants), Leadership Programs (320 participants), Performing Arts (748 participants), Sports and Recreation (1,560 participants), and Family Support (1,275 participants). These programs are carried out through the following programs: Power Hour, Torch Club, Keystone Club, Goals for Graduation, Visual Arts, Dance and Theater, and Sports and Recreation. For fiscal year 2014-2015, 100% of programmatic goals presented to PRPHA were accomplished. Major program results were as follows: 95% of bonafide participants approved and pass grade, 97% of participants graduated from high school, and 95% of those who graduated from high school will pursue college education. In the Health and Life Skills program, 84% of participants abstain from using alcoholic beverages, 95% abstain from using tobacco, 96% abstain from using marijuana, and 75% indicate that they are not sexually active.

 21ST CENTURY COMMUNITY LEARNING CENTERS
 21st CCLC is a program which main objective is to improve academic progress, as well as technology skills of participants. During fiscal year 2014-2015, 1,278 participants between the ages 6 and 18, and 244 parents benefited from the program. At least, 97% of participants attended services for 30 days or more. Program results statistics were as follows:
 * Approximately 68% of participants from first to third grade improve their reading skills
 * Approximately 44% of participants increase their spanish grade by 25 grading points
 * Approximately 97% of participants pass grade
 * All participants took part in sport and recreational activities as well as art programs and educational activities
 * Parents of participants took part of educational forums and employment opportunities forums, family time management, and healthy life styles.

 TEMPORARY ASSISTANCE FOR NEEDING FAMILIES (TANF)
 Smarts Moves Program sponsored by ADSEF is design to provide prevention services through the Smart Moves module. Main objectives were: promote autosufficiency in head of household women and youth with activities directed toward preparation for employment, encouraging responsible maternity and paternity, and activities directed to prevention of unplanned pregnancies. During fiscal year 2014-2015, services were offered in education and career development, health and life skills, character and leadership, arts, and sports and recreation. The program benefited 727 participants and 168 parents. A Family Strengthening Conference was realized and a Youth Prevention Conference. During fiscal year 2014-2015, 100% of programmatic objectives were achieved.
