This year, 92,541 individuals accessed the many services available at our 7 One Stop Employment Centers. Our goal each year is to meet the needs of our communities by outreaching and providing services to as many businesses and job seekers as possible. The number of individuals requiring additional services, beyond Universal Services, and enrollment into the WIA programs was 1,040. Our entered employment rate for individuals enrolled in our programs was 81.44%, with an average wage at placement of \$17.66
