The California Bicycle Coalition Education Fund works to enable more people to ride bicycles in California for healthier, safer, and more prosperous communities for all. Our primary activities include education and advocacy among the leaders of California's transportation agencies at all levels of government about best practices in bikeway design, planning, and bicycling promotion. The California Bicycle Coalition Education Fund also directly promotes bicycling to the public through its outreach and events.

Our main priority is the Better Bikeways initiative. The program seeks to build networks of bikeways, bike paths, and quiet streets that serve every destination in communities across California, with an emphasis on disadvantaged communities who will benefit most from such networks. Our specific activities included advocating within Caltrans and our community for the best possible design rules for protected bike lanes, including protected intersections in those rules.

4b (Code:) (Expenses \$ 50,000 including grants of \$ 50,000) (Revenue \$)

Helping Disadvantaged Communities takes advantage of the Active Transportation Program. In collaboration with several other organizations also working with Caltrans, we advised local government staff and local community members on the state's Active Transportation Program. Specifically, we developed several modules for a coordinated presentation and directly presented all-day workshops at seven Caltrans headquarters locations throughout California. We also reviewed Active Transportation Program applications in order to advise Caltrans and local agencies on potential improvements to the program.

4c (Code:) (Expenses \$ 48,835 including grants of \$ 33,862) (Revenue \$)

We also generally promoted safe bicycling through several activities. We engaged the public to build support for the bicycle awareness license plate, a program that will generate up to a million dollars in funds to promote bicycling once it's established. We began planning for the 2015 California Bicycle Summit which was held in October 2015. We continued to promote the Three Feet for Safety Act which requires motorists to give three feet of clearance when passing a bicyclist. The Education Fund also worked to connect our local partners with equity organizations in their regions or cities, to strengthen our partners and increase their emphasis on equity issues. We also engaged a consultant to improve the coverage of bicycling in mainstream media, particularly media focused on women's issues and lifestyle issues.
