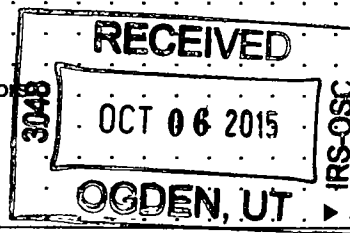

We are also committed to serve the student's individual needs with in-school mentors and visiting mentors. We strive to support equal numbers of young men and women who are academically strong and need financial assistance to continue their education beyond primary school. Beneficiaries are selected from rural northern Uganda after our coordinators interview school headmaster and classroom teacher to learn about students who have done well on their mock primary seven mock exam, have a strong work ethic and a zest for learning.

Parents are interviewed to ascertain their commitment to their child's education. Thirteen students are in various years of ordinary secondary school. Four students are completing their final year of advanced secondary school. Four students are in vocational schools studying nursing and medical lab technicianship.

The Children UP Board requires that we have the money in our funds to support a student through six years of secondary schooling before we invite a new beneficiary. Our goal is to assure there are available funds for each student to continue their education. Student must be disciplined, must communicate regularly with mentors and coordinators and must achieve grade results in Division 1 or 2 each year to be eligible for continuing support.

Through presentations, e-newsletters, social media and personal communication, we share stories and illustrate our students' cultural and educational experiences.
