OUR HOUSE PROVIDES COMPREHENSIVE, INTEGRATED SERVICES TO HELP HOMELESS AND NEAR-HOMELESS FAMILIES AND INDIVIDUALS ACHIEVE LASTING INDEPENDENCE. THESE INCLUDE HOUSING, QUALITY CHILDREN'S PROGRAMS, JOB TRAINING, CASE MANAGEMENT, AND MUCH MORE. OUR HOUSE SERVED 1,568 DIFFERENT PEOPLE IN FY2015, INCLUDING AN AVERAGE OF 110 RESIDENTS EACH NIGHT, AN AVERAGE OF 125 CHILDREN EACH DAY, AND UP TO 90 NEAR-HOMELESS FAMILIES EACH DAY. OUTCOMES INCLUDE 65% OF HOUSING CLIENTS MOVING OUT OF HOMELESSNESS UPON EXIT, 447 ADULTS FINDING FULL-TIME JOBS, 92% OF HOMELESSNESS PREVENTION CLIENTS AVOIDING HOMELESSNESS, 98% OF PRE-SCHOOL CHILDREN MEETING DEVELOPMENTAL BENCHMARKS, AND 91% OF SCHOOL-AGE CHILDREN IMPROVING OR MAINTAINING REPORT CARD GRADES.
