Of those who completed both a pre-test and a post-test, over 63% completed at least one NRS educational level. Eight students earned their alternate high school diplomas

4b (Code:) (Expenses \$ 104,467 including grants of \$ 86,446) (Revenue \$ 0)
Emergency Assistance: provided financial assistance to people in need related to housing, utilities, funerals, travel, employment, educational testing, etc. The program does not give money directly to those assisted. Checks are written, rather, to landlords, utility companies, funeral homes, etc. We also provided food and clothing through our food pantry to needy households. We bought some food, provided a limited number of food vouchers, and received food donations from churches, schools, etc.

Youth Recreation: provided supervised recreation at a nearby gym for young people living in our neighborhood. The gym was open weekdays from 3 PM to 6.30 PM. Average attendance was about 50.
