WIC provides supplemental foods, health care referrals and nutrition education for low-income pregnant, breast-feeding and non-breastfeeding postpartum women, as well as infants and children up to age five who are found at nutritional risk. Every month, 5,500 women benefit from NSO's WIC programs. Our two WIC clinics provide no-cost supplemental foods and nutritional education during a critical phase of growth and development.

4b (Code) (Expenses \$ **563,040** including grants of \$) (Revenue \$ **546,435**)**Housing and Community Development**

For nearly 90 years, Neighborhood Services Organization, Inc. and its predecessors have served those most in need -- Oklahoma City's impoverished, homeless and at-risk youths, adults and families. Throughout its history, NSO has focused on identifying the most pressing needs of our community's needy and implementing programs that address those needs effectively. Several programs, such as OKC Food Bank and others, were founded and nurtured by NSO before becoming independent service organizations. While we continue to identify current and future needs, our current programs include services in the areas of housing, monetary assistance and health services.

More than a million Oklahomans do not have dental insurance. Research continues to show that poor dental health leads to a myriad of other health problems. NSO's low-cost dental clinic allows individuals to receive high quality dental care at cost. Last year, we serviced more than 2,000 patients and conducted 4,000 procedures.
