Positive tomorrows is the only elementary school specifically for homeless children in Central Oklahoma. Positive tomorrows provides private, tuition-free education to homeless children in Kindergarten through 5th grade. Homeless children are often one to two years behind academically and socially. We start by removing barriers to education by providing transportation to school, food, clothing, school supplies, and other basic needs. Then following a thorough academic and social assessment, our certified teachers create personalized education plans to foster academic progress and social growth for each student. Our end goal is to prepare children for success in a public school setting. 98 Students served. 24,881 meals provided.

Social services for families of students at Positive Tomorrows are provided through the Family Support Program. The needs of families are assessed so that food, clothing, personal care items, and other basic necessities can be provided as needed. More sophisticated needs are also met through services, referrals, and resources for transportation, income assistance, job and life-skills training, and eventually housing. The end goal is to help families achieve a functional level of stability and self-sufficiency. 446 individuals served.

Extracurricular programs provide students with support outside of the classroom that reinforces their education and enriches their lives. An afterschool program ensures a safe place for children to receive tutoring, physical exercises, group activities, and to learn soft-skills, such as teamwork, confidence building, and friendship. During breaks in the school year, break camps provide students a safe and stable environment for out-of-classroom learning. Visits to museums, art classes, music lessons, and other cultural opportunities provide enrichment and experiences to all students. 84 students served. 102 students served in break camps.
