All decisions are made by the board of directors and are voted on by the full board while in session. All board decisions are in compliance with the Department of Housing and Urban Development Section 202 Housing contract. All decisions are subject to 3rd party review by HUD and external audit.

Pt VI, Line 7b

The completed documents are submitted by the third party tax preparer with the financial statement audit to the president of the board. The President of the board then presents the documents to the other board members for review and comment. If any questions arise the board contacts the third party preparer and the management agent. If needed the board has the preparers and management agent attend a special meeting to further clear any concerns that are expressed.

Pt VI, Line 11b

The Board of Directors follows the written conflict of interest policy as promulgated by the United States Department of Housing and Urban Development. This written policy is found in the Department of Housing and Urban Development form 9839b and contains all pertinent rules and procedures to prevent conflict of interest and to identify identities of interest. Members are required to disclose any business interest or associations that may be considered as either a conflict or identity of interest. Members are required to disclose all relevant facts prior to their involvement. If such facts are determined to be in conflict, the member must resign effective immediately.

Pt VI, Line 12c

All organizational documents and financial information are submitted to the Department of Housing and All organizational documents and financial information are submitted to the Department of Housing and documents to interested parties under the Freedom of Information Act.

Pt VI, Line 19

The organization provides affordable housing to low income families and individuals who earn less than the area median income as established by the Department of Housing and Urban Development. The housing is operated and regulated under The Department of Housing and Urban Development Section 202 program. The organization does not have indoor tanning services. No indoor tanning equipment is owned by the organization.

Pt V, Line 14b

Management is by a fee management firm and is bid out by best firm.

Pt VI, Line 15a

There is no Board of Director pay.
