St John's is an independent, co-educational day school presenting a 13-year sequence of college preparatory training. A non-profit institution, it was founded in 1946 to provide the community with a school of exacting standards in the development of individual, spiritual, ethical, intellectual, social and physical growth. While the means to achieve that purpose may change, it remains the basic mission of the School.

St John's School provides approximately 1,325 talented students in grades K-12 with a rigorous college preparatory curriculum and a wealth of enrichment opportunities carefully designed to prepare students for lives of leadership, service, and personal fulfillment. The School seeks to develop the whole person in preparation for a lifetime of personal fulfillment and contribution to society. In particular, it is dedicated to the enhancement and the expansion of future leadership for Houston and the country. The School offers talented, motivated and energetic students a genuine challenge for academic accomplishment and for development of a sense of self-worth and of personal responsibility. The School in turn holds itself responsible for providing that challenge.

4b (Code) (Expenses \$ 445,835 including grants of \$) (Revenue \$)
Breakthrough Houston (BTH) is a tuition-free program for academically gifted students from underserved families in the Houston community. The program makes a six-year commitment to its students, starting the summer before 7th grade and lasting until high school graduation. Middle school students participate in an academically rigorous six-week Summer Program and a School Year program made up of ten school-year Saturday enrichment sessions. High school students participate in a four-year college preparatory program made up of ACT prep, college visits, and resume building opportunities. BTH, part of the national Breakthrough Collaborative, is a joint venture of St John's School (SJS) and Episcopal High School. Both schools co-host the program by making their campuses available for BTH to operate. BTH operates under the 501(c)(3) designation of SJS and SJS acts as the fiscal agent for BTH.



