Educational courses, lectures, and workshops are offered in the fields of psychology, religion, expressive arts and the humanities. 218 courses and programs were offered during the Fall 2014, Spring 2015, and Summer 2015 semesters with 4,013 in attendance. The Jung Center sponsors outreach programs on site and at community centers and medical facilities. The programs include art classes, mindfulness classes, and yoga and other movement classes and are typically given for at-risk youth, mental health and medical professionals, and military veterans. Weekly sessions were held at community centers and at medical facilities. Five programs were offered on-site for mental health professionals.
