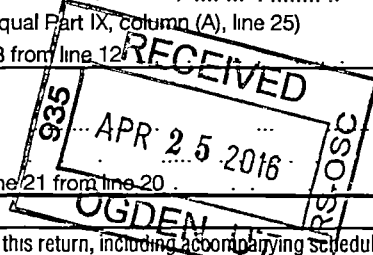

THE MAJORITY OF NOEP'S FUNDING COMES FROM THE CANCER PREVENTION AND RESEARCH INSTITUTE OF TEXAS (CPRIT). ADDITIONAL FUNDING WAS RECEIVED FROM THE LIVESTRONG FOUNDATION, THE DEPARTMENT OF STATE HEALTH SERVICES, THE UNIVERSITY OF TEXAS, AND TEXAS ONCOLOGY AND CLINICAL CARE OPTIONS.

NOEP EDUCATED OVER 24,000 NURSES THROUGH OUR ONLINE CONTINUING EDUCATION STUDIES AND MARKETED EDUCATION TO OVER 400,000 NURSES THROUGH MAIL, EMAIL, AND PRINTED MATERIAL HANDOUTS AT EXHIBITS. IN ADDITION,
