Now in its 54th year, the orchestra is comprised of a core of about 60 professional musicians from throughout the DFW area under the direction of Music Director and Conductor, Maestro Clay Couturiaux.
Founded in 1961, The Richardson Symphony typically performs a season of six subscription performances of popular and classical live music. Some performances feature guest soloists (vocal and instrumental) from all over the world, or popular local choral groups or soloists. Last year we also added a Family Concert.
In addition to its regular concert season, select orchestra members may play in contract performances. Examples include providing a quartet for an annual commercial open house, or providing orchestral accompaniment for a production at the Eisemann Center.

4b (Code: Lennox) (Expenses \$ 19,331 including grants of \$ _____) (Revenue \$ 26,325)
The Richardson Symphony seeks to promote music education with an eye towards educating future artists and audiences by offering children's concerts, music education, and by providing performance opportunities for young artists.
The LENNOX INTERNATIONAL YOUNG ARTIST'S COMPETITION draws young string players and pianists from across the nation and often beyond. Eligible young artists compete, with the first place winner being awarded a cash prize as well as the opportunity to present their chosen concerto (or other work) with the Richardson Symphony Orchestra during one of our spring concerts that same year.
The RSO regularly offers performance opportunities to music students from local and surrounding universities and colleges. Many of the season's concerts include young musicians who are college and graduate level music students.

4c (Code: Sym Days) (Expenses \$ 31,770 including grants of \$ _____) (Revenue \$ 19,514)
In line with its mission of developing young artists and promoting music education in general, the RSO is actively involved in elementary education programs through our SYMPHONY DAYS classroom visits and special children's concerts. Each elementary school in Richardson Independent School District is offered the opportunity to participate in a program which involves an on-site classroom visit by one of our musicians, to demonstrate their instrument and prepare children to appreciate and enjoy an upcoming concert performed specifically for them in the Eisemann Center. In many cases, the concert they attend as part of the Symphony Day program is the first classical concert these children have attended. The program focus is third graders. In the last two years, we have also made the program available to many private schools and home school groups.
