Spring Competition Trip: Each year the entire band travels to perform in a music competition that may require up to three nights stay in addition to food and travel expenses. Students are responsible for paying their own cost for this trip. The Spring Competition Trip benefits the entire band membership of approximately 214 students.

Bands of America San Antonio Super Regional Trip: Each year the entire marching band travels to perform in this marching competition which requires a day of food and travel expenses in addition to all entry fees. Students are responsible for paying their own expenses for this trip. The Bands of America Super Regional Trip benefits the entire band membership of approximately 214 students.
