Elderly Services - clients are provided with a hot, nutritious breakfast and lunch. Social activities, health screenings, and transportation to the grocery store and health care providers is offered as well.

Financial Assistance and Education - Emergency assistance is provided to help pay rent and utilities, as well as food from food pantries.

Clients receiving assistance are provided with financial education to develop budgeting and money management skills.

Employment Services - clients are provided with the skills and training needed to secure jobs. Catholic Charities then works with employers to place clients in jobs commensurate with the client's experience and skills.

Part VI, Line 1a - The governing body includes 20 voting directors and 5 non-voting, ex-officio directors.

The Bishop of the Roman Catholic Diocese of Dallas is the Sole Member of the corporation. The Sole Member has the authority to appoint and remove officers of the Board. In addition, the Sole Member must approve certain actions of the board, including borrowing, pledging assets or contracting in excess of \$350,000, adoption of annual budgets and strategic plans, buying or selling real estate, and amending or terminating the Bylaws.

Part VI, Line 11 - The 990 is reviewed by the finance committee before it is given to the Board of Directors. It is then given to the Board prior to its submission.

Part VI, Line 12 - All Board members are required to complete a conflict of interest certification on an annual basis.

Part VI, Line 15a - The CEO's compensation is included in the annual budget which is presented to the finance committee and the Board for approval. At the time of the CEO's annual review conducted by the board chair, the CEO's compensation is reviewed to ensure that it is adequate and in line with prevailing market compensation packages.

Part VI, Line 15b - The CEO, in conjunction with the Director of Human Resources, annually reviews the salaries of all executive staff including the Chief Financial Officer. The CEO considers annual performance reviews, comparable compensation from similar local organizations, and a number of other factors in establishing the CFO's annual salary and other compensation
