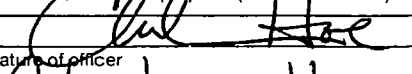

Provide support and assistance to community based educational initiatives and community charter schools

Through four managed grants to Hakipu u Learning Center : A Public Charter School, educational services were enhanced and supplemented during school year (SY) 2014-2015 for 63 students, their families and the greater community. These grants provided funding for the following purpose: 1. Staffing of ocean/agriculture science labs, technology support, and Educational Assistance; 2. Funding for professional development to improve teacher effectiveness and support school goals. 3. Partial funding for an accreditation coordinator, funding of annual accreditation fees, and expenses associated with visiting team. 4. Staffing support for an Administrative Team approach to school management. 5. Partial funding for a web-based math program
Hakipu'u Learning Center received probational accreditation May 2015.

Provide support and assist in providing learning experiences which integrate the Hawaiian knowledge and practices with students in a contemporary context.

1. Continue working with the City and County of Honolulu, and the Ko olaloa and Ko'olaupoko communities to update and validate a Master Plan for the Kualoa Regional Park, to include sites for cultural activities and learning opportunities for the entire community, including students around the island. This master Plan update includes focus on the Hawaiian cultural practices around sea voyaging, sustainability (food growing and gathering), quality of life and physical health through Hawaiian cultural activities (including Makahiki activities).
2. Continue working with The Trust For Public Lands, the Legacy Land Conservation Program, and State of Hawaii to become stewards of property which is part of an intact traditional Hawaiian hydrological system in Hakipu'u. This acquisition will preserve the coastal end of the Hakipu u ahupua'a and open it to community educational programs and activities. We are awaiting release of funding.
