SCHOLARSHIPS - THE PRIMARY GOAL OF THE FOUNDATION IS TO SUPPORT PROGRAMS AND ACTIVITIES THAT WILL DIRECTLY IMPACT STUDENTS. STATE FUNDING FOR HIGHER EDUCATION HAS DECREASED WHICH TRANSLATES TO AN INCREASED NUMBER OF STUDENTS WHO NEED ASSISTANCE TO FURTHER THEIR EDUCATION. THIS PUTS AN EXTRA FINANCIAL BURDEN ON THE COLLEGE AND, IN TURN, ON THE STUDENT. THE FOUNDATION NOW PROVIDES FINANCIAL SUPPORT FOR NINETEEN SCHOLARSHIP PROGRAMS FOR THE COLLEGE. CURRENTLY, THE AWARDS RANGE FROM \$250 PER SEMESTER TO FULL TUITION, BOOKS, AND FEES, WITH APPROXIMATELY 34 STUDENTS RECEIVING FINANCIAL SUPPORT THROUGH THE BCTC FOUNDATION DURING THE FISCAL YEAR ENDED JUNE 30, 2015.
