FAWIC conducts a Financial Monitoring Review (FMR) at least once a year on all service providers' contracts except those operating under the high risk contract provisions, which will be monitored on a quarterly basis. The monitoring follows a defined scope and program which FAWIC has developed for each service provider's monitoring. Whenever FAWIC discovers any irregularities, these are resolved as soon as possible and not left for the more formalized audit. After the financial monitoring is completed, the auditor discusses the findings with the service provider's director and financial officer.
