	Since its founding in 1985, IDEX has supported more than 500 grassroots, community-led projects in Africa, Asia, and Latin America. Annually, IDEX's partners serve approximately 1.2 million people in impoverished communities, including marginalized women, small farmers, indigenous communities, low-income urban residents, sexual and ethnic minorities, and youth. In FY15, IDEX programs' accomplishments include expansion of its grantmaking partnerships by bringing on four new groups in Zimbabwe, two new groups in Guatemala, and four new groups in Peru. It also includes a more comprehensive capacity building program, where grassroots organizations are supported to address areas that need organizational strengthening. IDEX launched the Nepal Earthquake Recovery and Resilience Fund (Nepal Fund) and channeled funds - within the first week after the earthquake - to our grassroots partners.
