The education program staff provided science-based field trips for public and private schools students, adapted field trips for special needs students, programs for homeschooled students and scouting groups, a 300-student Water Wizard Festival, and summer day camp for members of the local Boys & Girls Club. Last year, over 4,700 children participated in GRPC's site-based programs, which use the park and gardens as a natural lab to teach hands-on lessons and instill a sense of environmental stewardship. GRPC also provided low-cost fitness, gardening, and other enrichment classes for over 1,000 adults. GRPC's advocacy efforts focused on promoting the park's use and further development. Tax Return was amended after a financial audit discovered a grant that should have been recognized, a camera that should have been capitalized and reclass various expenses into the appropriate program, management / general and fundraising categories.

Form 990, Part III, Line 4a - First Accomplishment

Guadalupe River Run - drew over 10,000 people and encouraged them to explore the park and its "something for everyone" amenities. During the year, GRPC staff and volunteer board members met with local business leaders and elected officials to promote park development, maintenance, and safety. Stewardship included recruiting volunteers - individuals and corporate groups - to care help care for a historic orchard, rose garden and other demonstration gardens through integrated pest management practices. These beautification efforts were critical given the City of San Jose's budget cuts and resulted in reduced chemical usage, which benefited among others, the Chinook Salmon and Steelhead Trout in the river. Volunteers also helped with river clean ups, staffing for festivals, and office tasks. GRPC harnessed over 17,000 volunteer hours and donated fresh fruit from the orchard to a local soup kitchen and food bank.
