LEADERSHIP DEVELOPMENT, ORGANIZING & CIVIC ENGAGEMENT The core of APANO's work is building a powerful base of members who co-create and co-lead campaigns that address real issues in their community. APANO offers year-round leadership development opportunities with the purpose of developing clear social justice values, an understanding of community needs, and the ability to act strategically. This year we graduated 15 new leaders from our leadership development program to serve on boards, committees and other leadership bodies. We also launched organizing programs, developing a base of 80 youth, 20 college students, and 10 parents. APANO's Civic Engagement program is multi-lingual, multi-cultural and intergenerational, working to ensure all Asian & Pacific Islanders are fully engaged in the issues that affect them. Last year, this program trained 135 volunteers and registered 5,000 new voters.

JADE DISTRICT We participated in local community development work including opening an 8,200 sq foot community center, finishing construction of a community garden, and holding a night market to promote our business district with 25,000 visitors. We also hosted numerous charettes for community projects with 200 participants.

POLICY ADVOCACY APANO's Policy Advocacy work develops out of our community organizing and leadership development programs, with the goal of winning concrete changes in local ordinances, state and federal legislation, ballot measures, and other public policy. This year we brought 80 community leaders to educate decision makers on issues impacting the Asian Pacific Islander community of Oregon on health, education, and economic achievement. This led to new policies and reforms to close achievement gaps. We also built up member organizations around the state to open communication and coordination statewide.
