156 adults (16 and older and not enrolled in public school) received direct instruction to enable them to function on the job, within their families, and in society. 46 students completed their high school equivalency diploma. 18 graduates entered postsecondary education or training. 8 students entered employment and 6 retained employment.

Explanation of grants: 35 students received scholarships for the cost of the High School Equivalency exam ranging in amount from \$15 to \$65 per person and totaling \$1,650. Payments were made directly to the test vendors and testing centers so the funds could not be used for any other purpose.

English Language/Civics Instruction for 12 adults seeking to speak English better and to become participants in the community or to gain citizenship.

Family literacy activities included story times for 200 children with puppets and books; and 575 new books were distributed to needy children enrolled in Head Start or Early Head Start. Books were purchased with a contribution from the Bitterroot Kiwanis.

until the earnings from the endowment become large enough to pay the rent and other necessary costs of helping adults gain the literacy

skills necessary to gain employment or enter training. In an emergency, earnings from the endowment could be used to sustain program

services.
