Throughout the fiscal year the Wyoming Medical Center Foundation has raised funds to support various projects for it supported organization, Wyoming Medical Center (WMC) This fiscal year the Wyoming Medical Center (WMC) Foundation reached its goal of raising \$1 2 million toward Wyoming Medical Center's new NERD Health and Wellness Center which will be located within the McMurry West Tower The lead donor for this project contributed \$700,000 Other large donations of \$300,000 and \$100,000 were given, as well as \$40,000 from the Employee Giving Campaign The Nerd Health and Wellness Center will provide integrative medicine programs for patients, employees and members of the community The programs will address many aspects of a healthy lifestyle including fitness, nutrition and mental health There will be opportunities to meet with health coaches, attend lectures and yoga classes, with access to a brand new fitness studio Construction is scheduled to begin in January 2016 with plans to open the center in the summer of 2016 The WMC Foundation continues to raise funds to support Masterson Place, a 30 bed hospitality home that provides a place to stay for patients and families who travel to Casper, Wyoming for medical treatment During the last fiscal year, Masterson Place served 4,527 patients and families at a rate of \$40 00 per night for a room Donations toward the new Masterson Place Project included pledges for \$150,000 from the Masterson Family Foundation, \$800,000 in City One Cent Funding and another \$80,000 in County One Cent Funding and a \$100,000 pledge from a bank Plans for asbestos abatement and demolition of the existing buildings on the site are confirmed and will begin the third week of January 2016

Angels Cancer Care Program The Angels Cancer Care Program objective is to continue to serve cancer patients undergoing treatment by providing gas cards, food cards, hotel vouchers, prosthesis, wigs and more Long-term, the Angels Cancer Care Program plans to continue to serve patients along with providing education on cancer prevention This program also has a rich history of addressing varied concerns of cancer patients such as offering emotional support, financial assistance, transportation and medication retrieval The Angels Cancer Care Program raises much needed funds to support patients currently undergoing treatment In 2015 the Angels Cancer Care Program received a Susan G Komen Grant of \$5,000 to provide 100 uninsured women with a free screening mammogram To date, 15 have been completed In partnership with the Wyoming Foundation for Cancer Care, plans are in place to complete the remaining 85 In 2015, the Angels Cancer Care Program served a total of 96 patients including Thanksgiving dinners, Christmas cookie trays, monthly meals at Masterson Place, etc The Angels Cancer Care Program hosted 3 events in 2015 The Trojan Trek, Country for Cancer Concert and the Reindeer Relay raising a total of \$31,000
