The objective is to assist with the funding for areas in need, benefitting approximately 46,500

The Career Connect program provides career exploration events for secondary students (grades 8-12). The fall program is a career expo featuring 75-80 local employers. The Foundation provides programming and oversight for the events on behalf of the students in the school district, benefitting approximately 5500 students
