Applicant's trade or business is an exempt private foundation. The activity subject to the change in accounting method is the rental of a commercial building using the business activity code 531110 – lessors of other real estate.

Upon review of Applicant's fixed asset schedule and prior improvements, Applicant did not find any expenditures that would have been treated differently between the present and proposed method of accounting. For materials and supplies, the change in accounting method is done on the cut-off method and does not create a Section 481(a) adjustment.
