By virtue of the fact that its Board of Directors is comprised of community members who are entrusted with the governing documents, conflicts of interest, and financial statements, this is in great part its most readily available disclosure to the public. New Vistas discloses its financial situation and governance via the Form 990, which is posted on the New Mexico Attorney Generals website and onsite for public viewing.
