THE TRANSITIONAL LIVING PROGRAM IS A SUPERVISED APARTMENT SETTING FOR HOMELESS YOUTH AGES 17-24, INCLUDING PREGNANT AND PARENTING TEENS. YOUTH GAIN EDUCATION, WORKFORCE SKILLS, AND LIFE SKILLS SO THEY CAN MOVE OUT ON THEIR OWN AND BECOME INDEPENDENT, FULLY CONTRIBUTING MEMBERS OF SOCIETY. DURING FY15, THE PROGRAM SERVED 37 YOUTH, PROVIDED 3,533 NIGHTS OF HOUSING, AND PROVIDED 1,292 CASE MANAGEMENT AND LIFE SKILLS EDUCATION HOURS. OF THE YOUTH SERVED, 14 ENROLLED IN SCHOOL OR GED CLASSES, 7 BEGAN COLLEGE CAREERS, AND 28 SECURED EMPLOYMENT.
