Primary Care Services - Program provides care for acute and chronic conditions through site-based and outreach services, with hospital referral as necessary. Psychiatry is provided through paid staff, and other specialty clinics such as eye, dermatology, podiatry, gynecology, and muscular-skeletal are staffed by volunteer providers. A motel voucher program is available for respite care (homeless with medical diagnosis requiring shelter during recuperation). This program has a medical/social services treatment team that focuses on the needs of homeless individuals, children and their families, as well as homeless adolescents.

Social & Behavioral Health Services - Program provides a continuum of behavioral health services including outreach to streets, camps, and shelters, a drop-in center providing linkages and referrals, psycho-social assessments, individual and group counseling and therapy, case management services including comprehensive case management for clients who have severe mental illness and/or co-occurring disorders, social work, and individual and group recovery services.

Shelter Plus Care - the program provides rental assistance for people with disabilities, including mental health disorders and addictions. Participants in this program who have income are required to pay 30% of their income toward rent each month.
