She assumed the responsibility of President/CEO when GISA was faltering and on the verge of filing for bankruptcy. Upon the completion of Suzanne Lawder's tenure, in accordance with the best practices described below and pursuant to the terms of her termination agreement, she received a severance payment of \$30,354. In line with current best practices, the GISA Board, in 2009, hired an independent compensation consultant who reported that Ms. Lawder's compensation remained below comparable compensation being paid other not-for-profit top executives in the Tucson Metro area. Of further concern was GISA's commitment to Affirmative Action and the fact that the other executives, with like organizations, were all male. Ms. Lawder continued in her position for many years without retirement and other benefits accorded to CEOs in similar positions in the Tucson area. To address this situation, a company specializing in "catch-up" clauses was retained. After almost a year of working with the outside consultant on the above issue, the Board approved, with the recommendation of the Compensation Committee, a retirement "catch-up" clause with the purpose of back-paying retirement benefits by including a 457(b) and an After Tax Savings Program in Ms. Lawder's employment agreement. During the payroll year ended 12/31/14, \$5,833 was contributed to the 457(b) plan and \$205,895 was contributed to the After Tax Savings Plan for Ms. Lawder. Additionally, \$243,168 was paid from her 457(b) plan pursuant to the Termination Agreement in October 2014. The \$243,168 had been accumulated in the 457(b) plan from December 2004 through October 2014. Both of these amounts were reflected on her Form W-2.
