

The Foundation partnered with the AGFD on the Scholastic Clay Target Program (SCTP) that supports and assists Arizona high school SCTP teams/clubs in organizing activities, training coaches, providing funds for shooting supplies and other assistance as needed. The foundation applied for and was awarded a grant of \$152,600 from the Potterfield Trust for the support of SCTP programs. The Foundation distributed direct grants to the SCTP teams, as well as grants for training, supplies and tournaments. (\$45,800)

For the fiscal year ending June 30, 2015, there were 27 teams and over 1,000 youth and adult leaders involved in the SCTP program.

Habitat Workshops: The Foundation partnered with Mesquite Power to develop the Mesquite Oasis Wildlife Habitat located near the Mesquite Power electric generating station in Arlington, Arizona. The Mesquite Oasis Wildlife Habitat is a 40 acre educational area and trail system that is used by students, schools and the community. Mesquite Power partners with the Foundation to maintain and operate the habitat for educational workshops for local students and schools, hosting 2,520 students and 472 adults for a total of 2,992 visitors to the site, spread over 33 workshop days held throughout the fall and winter months. (\$60,450)

Tres Rios: The Foundation with the annual Tres Rios Nature & Earth Festival in the West Valley each March. (\$790)
