On average, more than 600 families of various age, race and ethnicity received emergency food assistance each month We provided fresh fruits and vegetables as well as meats and dairy to supplement our shelf stable distribution Between 35 and 50 children in the Vail area, who were identified by school counselors as being at risk of having no food over the weekends, went home each Friday afternoon with backpacks that included six meals and two snacks to curb weekend hunger Overall people had better access to food and ate more nutritionally We worked diligently to reduce hunger in our communities Clothing Bank - IMPACT of Southern Arizona funded the clothing distribution program including the value of clothing donated to this program Community donations and IMPACT purchases make this program possible We are open five days each week, and serve an average of 650 households each year, reaching more than 1750 unduplicated individuals This program is designed not only to provide needed clothing, but just as importantly to free up household income so it can be applied to other necessities such as rent, mortgage, utility payments, medications and additional groceries For this reason, this service is free to qualifying low to moderate income clients Typically more than 4250 items were distributed each month Overall we distributed 56,661 linens and clothing items to area households Senior Meals Program - IMPACT of Southern Arizona funded the Senior Center and related activities this past year The number of seniors receiving home delivered meals or who chose to attend the congregate meals program continues to increase each year, especially in our homebound population New activity and commercial kitchen facility with a larger kitchen and dining space to accommodate the growing number of local struggling seniors We hosted a variety of activities to foster an environment that helps seniors thrive as they age, and allows them to stay in their homes independently as long as safely possible We served more than 24,000 meals to seniors last year, with 87% of those being delivered to the homebound We have a new Program Manager and will be adding cooking classes for our seniors to give them ideas of easy recipes to prepare for one person, and with nutritional value added for the aging body Youth Programs - IMPACT of Southern Arizona funded community based youth programming including a daily afterschool leadership program in which at risk middle-school aged children were fed a healthy snack, learned about nutrition and health, got help with homework, built self-esteem and learned to be active advocates in their community IMPACT of Southern Arizona hosted its annual Youth Day celebration in Catalina which serves as an agency fair to connect people in the area to service providers who can improve and enrich their lives Typically more than 400 people attend, and are fed a free lunch BBQd by IMPACT Board Members Expenses incurred during the holiday season included Christmas gifts, seasonal clothing, jackets, hats, gloves, etc Summer programs were held to encourage children to get off the couch and out from behind the television Programs were designed to stimulate minds and bodies Our Back to School program supplied more than 208 children with new clothing outfits, backpacks and supplies Community Education is a growing area for us We offer ESL classes, citizenship classes, many community workshops and special events geared to improve residents lives Three individuals graduated our Citizenship course and became naturalized this year Dozens more continue in the ESL classes with the goal to one day also become contributing US Citizens This year we offered job assistance and referral, help with resumes, free cellular telephones, homeless supplies, and help with filing of DES applications and medical insurance information and sign ups We also hosted a fourteen week course on parenting education to teach about developmental benchmarks for children ages 2-6 years old, and gave each family a gift each week that would allow the parents to practice their new play and reading skills to help their children thrive For our seniors we hosted in partnership with other agencies, a one day conference on living with chronic illnesses We continue to explore new workshop opportunities and develop programs to help improve our clients lives and inspire their futures Being located in the far northwest and southeast rural corners of Tucson AZ, IMPACT of Southern Arizona is often the sole local provider of many of these services As a resource center, offering information and referrals as well as the services described above, we impact the lives of many We have enrolled more than 6500 registered clients, with more than 1500 of these as children under the age of 18 Our vision is that individuals and families in our underserved southern Arizona communities will overcome obstacles, gain confidence, and learn new skills to become self-sufficient
