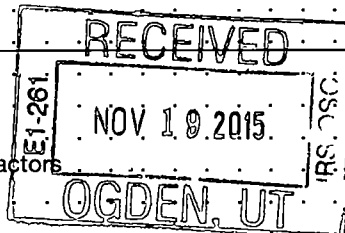

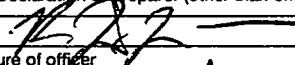

These programs included support for high school Student of the month awards for two high schools, a health fair for a local elementary school, support for a Christmas program at a local homeless shelter, support for local polio survivors, a library donation, band/madrigal/culinary support for high schools, a music, speech and essay contests for local high schools, birthday gifts for children in a local shelter, awards for safety officer recognition, support for a local low income childrens football league, a peace conference, and support for Veterans.

Line 16- The \$43,253 figure represents all expenses including Rotary District Dues, Rotary International Dues, Rotary Foundation contributions, Rotary training expenses, and club expenses like weekly meals, program expenses, event supplies, website costs, Chamber of Commerce membership, credit card processing fees, bank fees, youth exchange expense, and office supplies.
