Sponsored a table at the March of Dimes for the Nurse of the Year Event. Provided 400 cold kits to vendors of Real Change.

Provided Community Grants to members: Emerin Hatfield, \$500 for Reading to Baby for Spanish speaking parents, Frankie Manning, \$1,000 for socks at the Remote Area Clinic; Clare Brooks, \$500 for a retreat for Seattle Children's Hospital Emergency Room Nurses, Sandy Mortinson, \$800 for health resources for the New Horizon shelter. Encouraged members to volunteer with other community organizations by posting opportunities in quarterly newsletter.
