Spokane County United Way mobilizes our community to create measurable results that improve people's lives. By 2020, Spokane County will be known as a community that is increasing health, prosperity and education attainment and is breaking the cycle of intergenerational poverty. This will be measured by: 1) a 50% reduction in educational achievement gaps, 2) decreasing poverty 3) a reduction in levels of abuse, neglect and unhealthy behaviors.

Donor Designated Gifts: Spokane County United Way runs or coordinates two major fundraising programs, the United Way Campaign, and the Combined Federal Campaign for Eastern Washington. Many of these donations are specifically designated to qualified non-profit agencies. Acting as an agent, United Way ensures that these donations are collected and accurately distributed at least quarterly, under standards established by United Way Worldwide.

4b (Code:) (Expenses \$ 702,644 including grants of \$ 632,780) (Revenue \$ 0)

Children Succeed In School: United Way funded partnerships for after-school programs focused on youth development. These programs served 2,814 youth during the year. Programs focused on the developmental assets of support, empowerment, boundaries, high expectations, constructive use of time, commitment to learning, positive values, social competencies, and positive identities. Partnering organizations included Boy Scouts of America, Inland Northwest Council, Boys and Girls Club of Spokane, Camp Fire Inland Northwest, Communities in Schools of Spokane County, Girl Scouts Eastern Washington & Northern Idaho, Holy Trinity Episcopal Church Spokane, Whitworth University, Project Hope Spokane, and YMCA Spokane. United Way funded Communities in Schools to provide coordination of services at Shaw Middle School (Check & Connect Program) including tutoring, mentoring, health care and parenting support. 130 youth were served. 568 youth received scholarship assistance to attend Camp Dartlo summer camp, run by Camp Fire Inland Northwest. United Way provided funding for Salish School of Spokane, a Salish language immersion school that served 18 school-age youth and 15 preschool children during the year. United Way provided funding to Excelsior Youth Center, an accredited school for adolescent males in a residential treatment center. 65 youth were served.

4c (Code:) (Expenses \$ 157,955 including grants of \$ 157,955) (Revenue \$ 0)

Children are Nurtured and Safe: United Way invests in programs to prevent and mitigate the impact of Adverse Childhood Experiences (ACEs) through early intervention and support to vulnerable families. The organization funded in part the following Spokane-area programs: Parents As Teachers Program at the Children's Home Society, taught parenting skills to at-risk parents of 59 children ages birth to two years. The Child Welfare Program at Lutheran Community Services, Inland Northwest Office provided mental health care and therapeutic foster care to 249 children and their families who have experienced abuse and neglect. The Family Relationship Training program at the Martin Luther King Jr., Family Outreach Center provided parenting education to 62 caregivers using the Circle of Security model. The Safe Schools Spokane Program at Odyssey Youth Center provided safe schools training to 165 middle and high school youth, 821 teachers, counselors, and other school staff. Sally's House at the Salvation Army in Spokane, an emergency receiving care facility for children removed from their families, served 329 children during the year. 47 families were reunified, and 61% of foster care placements were successful. The Child Advocacy Program at the YWCA provided for services for youth who have been exposed to traumatic life-altering events such as domestic violence.
