 On-site Client Employment Training Columbia Industries operates a janitorial enclave at the Richland Federal Building which provides group-supported job training to eleven unfunded and five DDA funded individuals with disabilities Pre-vocational training is provided to eighteen DDA funded individuals, two unfunded individuals and seven high school students at CI Solutions CI Solutions trains individuals with disabilities in small parts assembly, commercial sewing and mailing services Pre-vocational retail training was also provided at Shop CI, a thrift store Shop CI serves seventeen DDA funded clients, one unfunded client and six students Shop CI trains individuals with disabilities in hanging clothing, tagging clothing, cleaning household items, janitorial work and stocking shelves/racks with product One Pre-Vocational client was moved into IE Services this year Each individual at Columbia Industries has an employment plan which addresses the individual barriers to employment that each person faces CI Staff work with clients on learning new skills that will assist them on their Pathway to Community Employment Columbia Industries continues to have the goal of supporting people with disabilities in achieving their highest employment potential and in being self-sufficient

 Vocational Rehabilitation and Placement Services CI Employment Services provides many services that center around employment in the community for those that have disability-related barriers to employment We serve approximately 100-150 clients each year, referred by DVR, DDA, and school Districts, in the following areas Job Placement, Trial Work Experience, Community Based Assessments, Retention, Intensive Training, Independent Living Skills, and Community Integration for Pre-vocational, Individual Employment, Community Access, and School-to-Work program designed to give high school students work/volunteer experiences prior to graduating We also offer weekly Jobs Club sessions and a WorkStrides Job Development Workshop several times a year

 Community CenterCI's Community Center affords people who experience disability, the opportunity to socialize and interact with their peers and gain enrichment through education, as well as integrate into the community The following are examples of the activities and goals One goal of the Center is to offer socialization for people who experience disability Many become isolated after high school, especially if they don't participate in employment services Since May of 2015, the CI Community Center has provided over 44 people with this service, on a regular basis but have 67 people signed up for drop in service as needed by the person or family The Center has doubled the amount of people served since last year Another important aspect to life is enrichment The Center offers games and activities, which focus on learning This includes arts and crafts, book club, cooking and computer classes, as well as Zumba and Yoga classes The CI Community Center connects to the local community by participating in regular outings, which the members get to choose We collaborate with our members to ensure they have say in what outings we offer In addition, each member also has choice in which activities they participate The community Center works with the local AARP, WEX (work experience) program, and Division of Vocational Rehabilitation to offer employment volunteer opportunities to those who participate in those employment programs In addition the Center works closely with the Developmental Disability Administration and to offer skill building for members
