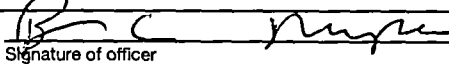

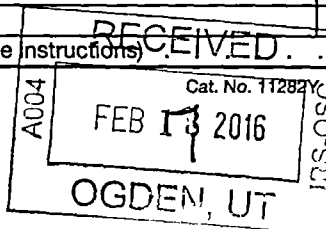

Primarily resources from the Centralia College Foundation go to support scholarships - to assist students in the pursuit of their education at Centralia College. Scholarships leverage Federal Financial Aid packages to maximize awards for students pursuing a certificate, AA, or BAS degree. Students only need to complete one application for any of the scholarships that the foundation awards. For the fall of 2014, 254 Centralia College students who applied for foundation scholarships received over \$740,000 combined scholarships, grants, tuition waivers, and financial aid.
