The Agros model is a uniquely holistic approach to alleviating rural poverty By providing long-term land loans to the poor along with integrated services such as community organization, agriculture and health training, and financial education, entire rural villages are empowered to become self-sustaining and escape the devastating effects of extreme poverty Program initiatives undertaken during the year include * Completed the purchase of two land parcels in Nicaragua for \$826,001, using primarily permanently and land-purchase restricted funds This will enable additional families to be served by the Agros model These funds were granted to affiliate Land Hope Life where land parcels are held * Provided community and economic development training and assistance to 580 small-producer families (3439 individuals) in Agros villages in Nicaragua, Honduras and Mexico Training included income-generating technical assistance in basic grain, coffee and vegetable production * Completed direct support for three communities that reached development milestones, * Continued to provide health strategies for families, encouraging improved health practices and prevention of diseases, focusing particularly on pregnant women and children under five years old, * Sponsored service teams to Agros villages in which 141 U S individuals participated
