	The West Seattle Food Bank (WSFB) is a not-for-profit organization committed to providing food security and community connections to our neighbors in need. WSFB distributes food, baby food, baby supplies, books and other items to low-income residents of West Seattle. In fiscal year ending June 30, 2015, WSFB provided food and other basic necessities to families in need 40,385 times. We distributed over 1.4 million pounds of food, and \$240,984 worth of baby supplies and books were distributed to families in need. Our backpack program provided weekend food to children in need over 4,000 times during the year and our home delivery program provided groceries to elderly and disabled individuals over 8,000 times during the year.
