PROVIDED SUPPORT FOR THE LAUNCH OF A PARTNERSHIP TO PROVIDE TRAINING AND SUPPORT TO THERAPEUTIC FOSTER FAMILIES PROVIDING SPECIALIZED SERVICES TO YOUTH WHO HAVE BEEN TRAFFICKED.
