 Academic Enrichment Phase - We successfully recruited our 14th Cohort of scholars this year, including students from Renton, Highline and Seattle School districts. Meanwhile, Cohort 12 completed their final summer in 2014 with 98% earning placement into independent schools or highly-capable public school programs. Cohort 13 completed their school year in 2014-15 achieving a 100% placement rate in college preparatory settings with 45% in public school programs and 55% earning placement at independent schools

4b (Code) (Expenses \$ 564,091 including grants of \$ 54,223) (Revenue \$)
 College Support (CS) With a 95% college matriculation rate over the past six years, 173 college scholars were served through ongoing comprehensive support and outreach, 100% of freshmen received on site campus visits from Rainier Scholars staff. An essential College 101 retreat provided critical support for transition into college life. Internships and additional career networking opportunities were provided to build professional networks. We now have nearly 100 college graduates who have achieved a 90% graduation rate within five years. Rainier Scholars alumni are now employed throughout the region and the country at companies/institutions such as Amazon, Boeing, Google, Skanska USA, Yahoo, Liberty Mutual, Honeywell, Teach for America and Uncommon Schools. Other alums have been accepted to medical school or are enrolled in graduate school programs pursuing master degrees. As we look at the leaders and community members our scholars are evolving into, we feel humble confidence that the model, which begins at age 11, truly offers the opportunity for students who otherwise would not have the access to the high quality college preparation and leadership development experiences, to become the young adults they want to be, and in so doing, become members who so greatly enrich our communities and our world.

4c (Code) (Expenses \$ 543,657 including grants of \$ 32,963) (Revenue \$)
 Academic Counseling and Support Services- 155 scholars received comprehensive support services in middle and high school through on-site school visits, mentorship and skill-building workshops. Focus on increasing skills for academic success included organization, time management, accountability, self-advocacy, collaborative learning and risk taking with 81% of 7-9th graders demonstrating proficiency in at least four skill areas. Summer learning opportunities included nearly 60 students participating in 22 different programs locally and nationally.
