SCHOLARSHIPS AND AWARDS ARE MADE THROUGH A COMPETITIVE PROCESS TO DESERVING APPLICANTS TO ASSIST IN THEIR EDUCATION. WE AWARDED 14 SCHOLARSHIPS DURING THE YEAR. WE ALSO AWARDED TWO AWARDS TO DESERVING WOMEN. THE SCHOLARSHIPS PROGRAM IS ADMINISTERED BY THE SCHOLARSHIP COMMITTEE MADE UP OF CLUB MEMBERS. ALL SCHOLARSHIP APPLICATIONS ARE JUDGED BY A PANEL OF COMMUNITY VOLUNTEERS SELECTED ANNUALLY BY THE SCHOLARSHIP COMMITTEE. THE SCHOLARSHIP COMMITTEE AWARDS THE SCHOLARSHIPS BASED ON THE RECOMMENDATION OF THESE PANELS.

AWARDS ARE MADE BY THE AWARDS COMMITTEE ALSO MADE UP OF CLUB MEMBERS. APPLICATIONS ARE SOLICITED FROM THE PUBLIC, THE APPLICANTS ARE INTERVIEWED, AND AWARDS ARE MADE TO THE TOP APPLICANTS. CONSIDERATION IS GIVEN TO FINANCIAL NEED, EDUCATIONAL GOALS AND THE IMPACT OF THE AWARDS ON THE WOMEN AND THEIR CHILDREN. WE PARTNERED WITH OTHER SOROPTIMIST GROUPS IN SKAGIT COUNTY TO WIDEN THE POOL OF APPLICATIONS RECEIVED.

OUR MOST ACTIVE PROGRAM IS THE COMMUNITY SERVICE PROGRAM. DONATIONS ARE MADE TO OTHER 501(C)(3) ORGANIZATIONS, SCHOOLS, HOSPITALS, ET AL, PRIMARILY IN ANACORTES AND SKAGIT COUNTY. DONATIONS ARE MADE TO PROGRAMS THAT PRIMARILY BENEFIT WOMEN AND CHILDREN. WE ALSO SUPPORT ORGANIZATIONS OUTSIDE OF OUR LOCAL AREA AS WE DEEM APPROPRIATE, GIVING OUR CLUB AN INTERNATIONAL REACH. WE DONATED TO 66 ORGANIZATIONS THROUGH OUR EIGHT PROGRAM OF SERVICE COMMITTEES, OUR PREIDENTIFIED BUDGETED ITEMS, AND OUR COMMUNITY SERVICE COMMITTEE. WE HAVE CREATED A STRATEGIC PLANNING COMMITTEE TO IDENTIFY NEEDS THAT REQUIRE A LARGER DOLLAR COMMITMENT THAT WILL HAVE A GREATER IMPACT. WE WERE ABLE TO AWARD 8 GRANTS FROM THIS PROGRAM FOR A TOTAL OF \$40,000.

WE ALSO LOAN HOME HEALTH EQUIPMENT TO LOCAL RESIDENTS FREE OF CHARGE. THIS INCLUDES WHEEL CHAIRS, CRUTCHES, CANES, TOILET SEAT EXTENDERS, BATH SEATS, WALKERS, AND OTHER NEEDED EQUIPMENT.

WE SPONSOR A NUMBER OF PROGRAMS THROUGH DIRECT GIVING FROM OUR THRIFT STORE FREE OF CHARGE. WE SPONSOR A "DRESS YOU FOR SUCCESS" PROGRAM. WE OUTFIT REFERRED CLIENTS WHO ARE LOW INCOME OR UNEMPLOYED WITH BUSINESS ATTIRE SO THAT THEY CAN GO TO JOB INTERVIEWS. WE ALSO SUPPLY OUTFITS SO THAT THEY CAN GO TO WORK WHEN NEWLY HIRED. ALL ITEMS ARE GIVEN FREE OF CHARGE. THIS YEAR WE HELPED 16 CLIENTS WITH OVER \$600 OF CLOTHING.

WE HAVE A VOUCHER SYSTEM USED BY OTHER ORGANIZATIONS IN THE COMMUNITY. THEY REFER CLIENTS IN NEED OF BASIC HOUSEWARES AND CLOTHING. CLIENTS ARE ALLOWED TO SHOP IN OUR STORE BASED ON THE VOUCHER GIVEN TO THEM BY THE SALVATION ARMY, ST. VINCENT DE PAUL, RED CROSS, OUR LOCAL SCHOOLS, AND CHURCHES. ALL ITEMS ARE PROVIDED FREE OF CHARGE.

WE ALSO PROVIDE ITEMS FOR SCHOOL BOOK DRIVES, BACK-TO-SCHOOL SUPPLIES, AND TO THE COUNTY WOMEN'S SHELTER ON AN AS NEEDED BASIS. AGAIN THESE ITEMS ARE PROVIDED FREE OF CHARGE FROM OUR THRIFT STORE.
