The most recent review was performed in October 2014. The resulting report was provided to the Board of Directors and Management for review. The bonus is not calculated based on the amount of the Hospital earnings. The remaining three measures are 1) Quality of care, 2) Patient satisfaction, and 3) Utilization.
