The articles of incorporation were amended, with the amendment filed on April 27, 2015. The amendment rewrote the articles to be consistent with the requirements to qualify as a Section 501(c)(3) exempt organization under the Internal Revenue Code (the organization was, prior to the amendment, qualified as an organization exempt under Section 501(c)(4) of the Internal Revenue Code). For example, the articles were changed to require that all assets on dissolution were to be distributed to another Section 501(c)(3) organization (as opposed to a unit of government or another Section 501(c)(4) organization under the prior articles of incorporation). In addition, the amended articles of incorporation extended the purpose of the organization to "scientific, educational and charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code and the Regulations thereunder." Previously, the articles specifically listed "to provide a nonprofit fire department in the Deltana area for the protection of life and property from fire or other emergency as falls within the area of responsibility of an organized fire department..." and "to be organized and operated exclusively for charitable and educational purposes as such term is used in Section 501(c)(4) of the Internal Revenue Code" as purposes for the organization.
