NWRRRC PROVIDES AN ESSENTIAL COMMUNITY RESOURCE BY HELPING INDIVIDUALS SUCCESSFULLY REINTEGRATE INTO SOCIETY FOLLOWING THEIR RELEASE FROM A FEDERAL CORRECTIONS FACILITY. NWRRRC PROVIDES JOB PLACEMENT ASSISTANCE, CASE MANAGEMENT, COUNSELING, AND A SAFE AND DRUG FREE RESIDENTIAL ENVIRONMENT THROUGH CONTRACTS WITH THE FEDERAL BUREAU OF PRISONS AND U.S. PROBATION AND PRETRIAL SERVICES. WE SERVED APPROXIMATELY 446 PEOPLE DURING 2014-15. OF THOSE 446 IN OUR PROGRAM, WE HAD A TOTAL OF 356 RELEASES FROM THE PROGRAM. 283 OF THOSE RELEASES WERE DUE TO SUCCESSFUL COMPLETION OF OUR PROGRAM (79.5%) AND 73 WERE RETURNED TO CUSTODY (20.5% FAILURE RATE). THE NATIONAL AVERAGE RECIDIVISM (OR FAILURE) RATE IS APPROXIMATELY 38%. 87% OF RESIDENTS IN OUR PROGRAM WERE MALE AND 13% WERE FEMALE. THE AVERAGE AGE WAS 40.
