Botany and horticulture We collaborated with the City of Portland Urban Forestry division to develop a Tree Management Plan for the nearly 1400 trees in the Garden and, further, drafted and gained approval for the first ever Programmatic Permit issued by Urban Forestry With Portland Parks we helped select a design team to begin the second phase of design work for new botanical and horticultural offerings in the Upper Garden Garden staff worked with landscape design professionals to identify plans for replanting of existing botanical collection areas Propagation of plants in higher volume for our annual plant sale as well as for use in planting anticipated in the future began The first horticultural intern was selected to work in the garden during the summer Partnerships continued with staff from OSU, the Berry Seed Bank, and the National College of Natural Medicine New connections were explored with Siskiyou Field Institute which shares some of the same flora and fauna that are part of the Leach heritage We saw an increase in visitors to the Garden to an estimated 22,000

Education The work with the design team in the Upper Garden plan also included goals for educational elements. The design included the provision of indoor and outdoor spaces where educational programs can take place, the provision of interpretive signage to educate visitors about the botanical experiences presented, and the inclusion of a wide variety of botanical collection beds and settings which make that educational element robust. The education staff continued with summer day camps not only those run by the Garden but arranging for partner organizations such as Portland Audubon and Outdoor School to provide programs. A partnership with Alice Ott Middle Schools sun program engaged nearly 20 youngsters in a year-long learning program at our Childrens Garden. A variety of other classes from drawing to plant propagation were presented. A free lecture series brought approximately 150 adults to the garden to hear about soil, water and design, and *Darlingtonia californica*. We also sponsored two lectures off-site covering issues of garden design and the significance of public gardens. The second of the two at Portland Art Museum drew a standing room only audience of over 400 people.
