EDUCATION - NeighborImpact's Early Care and Education Division runs a Headstart program offering preschool education to 3- and 4-year old children and supports to their families to help build parenting skills and create stable, supportive home environments conducive to student success. NeighborImpact's Headstart program serves Crook and Deschutes Counties. In the fiscal year ended June 30, 2015, NeighborImpact served 507 children through this program. NeighborImpact also coordinates training for the region's childcare providers. In the fiscal year ended June 30, 2015, NeighborImpact provided tuition and books to 145 providers in the provider network to help them earn college degrees. NeighborImpact also provided 18 check out laptops to help students succeed. A significant subset of those served through the childcare resources program are residents of the Warm Springs Reservation. In total, NeighborImpact's childcare resources division served 1,582 individuals.

WEATHERIZATION & ENERGY EDUCATION/ASSISTANCE - NeighborImpact is Central Oregon's weatherization provider for income qualified households. Weatherization involves upgrades which are needed to protect a home from the elements, particularly precipitation and wind. The benefits of weatherization include cost savings for extremely cost burdened households and benefits to the environment of reduced demand for energy. Through this program, the agency also provides energy education available to residents of Central Oregon, regardless of income.

FOOD - NeighborImpact's regional food bank distributed through its approximately 40 partner agencies approximately 3.7 million pounds of food to needy Central Oregonians. A total of 41,741 individuals were served. Food distributed is equivalent to 3.08 million meals. Nearly half the food collected by NeighborImpact is recovered locally, through partnerships with retailers and contributions from growers and the local community.
